LETTER OF INSTRUCTION

ORDER AND PETITION FOR RETURN OF CASH BAIL

Use the enclosed form Order and Petition to obtain return of cash bail for a surety who has deposited money with the court on behalf of the defendant in a criminal matter for the purpose of a bail bond.

The petitioner (person who deposited the money) is to complete the enclosed petition, have it notarized, and return it to the Clerk, U.S. District Court.

The Clerk will verify the signature on the petition and verify that the deposit was made. The petition and proposed order will then be sent to the appropriate Judge for consideration. If a payer on a return of a bond is different than the original payer, then legal documentation of the transfer of entitlement must be included with the petition. You must supply the court with the following approved documentation:

- 1. Power of Attorney (NOTARIZED)
- 2. NOTARIZED statement of the original payer designating or authorizing the release of funds to the petitioner together with an affidavit that the original payer is not an infant or incompetent (Example of a single and Dual assignment form are attached)
- 3. If the payer is deceased: Documentation demonstrating that the petitioner is a beneficiary of such funds of the payer/decedent (NOTARIZED)

After the order is signed, the petition and order will be returned to the Clerk and a check will be issued to the petitioner.
